Ragging- Violation of Human Rights Ragging is **strictly prohibited on campus & off campus**

AIM: To root out ragging in all its forms from the college by instituting stringent anti ragging measure and provisions for strict punishments to defaulters

WHAT CONSTITUTES RAGGING?

- College life is very important in every body's life because it not only determines the future of a person but also is a time when most students understand the realities of life. But it has been observed that students do not enjoy their campus life till the end of first year. This is because of ragging.
- Ragging is any disorderly conduct, whether by words spoken or written, or by an act which has the effect of teasing, treating or handling with rudeness any student.
- Indulging in rowdy or undisciplined activities which cause or are likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the psyche of a fresher or a junior student. (Supreme Court Judgment Order dated 8 May, 2009).

PROHIBITION OF RAGGING:

- Ragging within the college campus including its Institutions/departments or outside the campus is strictly prohibited.
- No person including students/staff/faculty shall participate or abet or propagate ragging in any form.



PUNISHMENTS:

Ragging is a cognizable offence under the law and the punishments are exemplary and justifiably harsh to act as a deterrent. It may include:

- Cancellation of admission or suspension.
- FIR with the police and arrest.
- Severe punishment where justified such as fine/imprisonment, etc.
- Withholding Scholarship or other benefits (Writ Petition-Civil No. 656 of 1998 of Supreme Court).
- Debarring from representation in test/examination/extracurricular activities.
- With holding of results.

MEASURES TAKEN BY INSTITUTE:

- Ragging which starts as fun for one group of students may have a far reaching influence on the other group of students, family and the Institution itself. The consequences may end up in death. The College works towards the welfare of students and make them skilled, disciplined, qualified and confident graduates. To achieve this College has taken the following measures to the menace of ragging in the campus.
- MGC observes that Ragging is neither a fun nor a pleasure or entertainment and also not a means of familiarization or an introduction with college freshers, but it is a heinous act of Human Abuse and crime, and the same is disseminated to the students.
- Formed Anti Ragging Committee consisting of senior faculty members headed by Principal.
- Committee has taken steps and allotted duties to all the staff members at almost all areas in the college (i.e. canteen, parking places, hostel, different blocks, play ground etc.) and ensure that at least one faculty member will be present at any particular time at all the locations to avoid ragging activities.

The following measures need to be taken against Ragging in your college :

- 1) Precautionary measures have to be taken for Anti-Ragging prior to happening of any incidence on ragging.
- 2) Anti-Ragging Committee to be constituted in each college.
- 3) Name of the teacher with Address and Phone Number to be displayed in the Notice Board to register complaint immediately in case of Ragging.
- 4) Complaint Box and Suggestion Box for Anti-Ragging to be kept and College Principal and Head of the Departments have to discuss and take precautionary measures to eradicate the menace of Ragging

Further, As per the orders of the Government of Maharashtra, colleges in Maharashtra constitute Anti-Ragging Committee with the following members :

The Principal, Heads of the Departments, Heads of Public departments, Police, media, Parents and Students.

In the same way, Tamil Nadu colleges have to analyse and submit the report for constitution the Anti-Ragging committee to eradicate the menace of Ragging.

I am, therefore, request you to take necessary action in this regard and send the report within 7 days from the date of receipt of this letter.


2. You would recall that vide letter referred to above, all States and Union Territories had been requested to direct all the Civil authorities at the district level to comply with the judgement of the Hon'ble Supreme Court of the India by way of:-


- participating in anti-ragging committee of educational institutions;
- constituting district level anti-ragging committee to be headed by District College/Dy. Commissioner/District Magistrate;
- setting up monitoring cell at the level of the Chancellor of State University;
- keeping vigil on incident of ragging, taking immediate action on receiving distress message from victim of ragging;
- appointing state level committees to examine the problems of alcoholism on the campuses and to suggest immediate de-addiction measures; and
- committee to study the psychological impact of ragging on students and recommend urgent and mandatory measures to be implemented in educational institutions.

3. You would be aware that there has been a sustained awareness campaign against ragging through advertisements. The State Governments and Union Territories may also consider giving publicity to campaign against ragging besides advising educational institutions in the States.
